Catawba Two Kings Casino donates estimated \$15,000 in toys for children in Cleveland and York counties

Casino, its employees, patrons, developer and consultant Delaware North, and gaming machine supplier Gaming Capital Group all contribute toys

KINGS MOUNTAIN, N.C. (Dec. 9, 2025) – Catawba Two Kings Casino in Kings Mountain on Dec. 8 donated hundreds of toys – valued at \$15,000 – to the regional Toys for Tots campaign to provide holiday toys to deserving children in York County in South Carolina and Cleveland County in North Carolina.

The casino, owned and managed by the Catawba Nation, purchased \$3,000 worth of toys, casino developer and consultant Delaware North purchased \$5,000 worth of toys, and Gaming Capital Group (GCG), which supplies gaming machines to the casino, purchased \$3,000 worth of toys. This supplemented the toys donated by casino employees and patrons.

The donation was coordinated with regional representatives of Toys for Tots and the U.S. Marine Corps Reserve, which operates the program nationwide. Jennifer Elbertson, director of marketing for the casino, oversaw the promotion of the drive with donation boxes placed at the casino.

“Thank you to everyone who has donated to this great cause, including our patrons, our team members, Delaware North and GCG,” said Trent Troxel, vice president of the Catawba Nation Gaming Authority. “We also thank our partners with Toys for Tots – the Marines, Cleveland County and York County. Catawba Two Kings Casino loves to give back to the community, and the toys that were donated today will serve a lot of families that are in need.”

This is the fourth consecutive year that Catawba Two Kings Casino and Delaware North have held the Toys for Tots drive at the casino.

About Catawba Two Kings Casino Resort

The Catawba Nation’s temporary Catawba Two Kings Casino is located about 35 miles west of Charlotte at 538 Kings Mountain Blvd. in Kings Mountain, N.C., just off Interstate 85 at Exit 5. It features over 1,100 gaming machines, including electronic table games (ETGs), 14 live table games, North Carolina’s closest sportsbook to Charlotte and casual dining.

The permanent casino resort is being developed on an adjacent site and is expected to open with an introductory phase in spring 2026. The final Catawba Two Kings Casino Resort will feature 4,300 slots, 100 live table games, 11 dining outlets, 11 bars and a 385-room hotel. It is expected to create 2,000 permanent jobs and hundreds of construction jobs in the region. The project is being led by the Catawba Nation Gaming Authority with Yates-Metcon as the construction general contractor; Delaware North as the gaming management, development and hospitality consultant; and SOSHNY Design architects.

The Two Kings name celebrates the Catawba Nation’s history and hopeful future in their ancestral lands in North Carolina, paying tribute to the 18th century Catawba Chief King Hagler
